TORCHLIGHT PARADE  
AGREEMENT TO ABIDE BY RULES AND REGULATIONS**

- Vendors are approved by the Spokane Lilac Festival Merchandising Committee.
- The Spokane Lilac Festival has the right to bar and/or remove from the parade route those not conforming to the rules and regulations.
- The Spokane Lilac Festival Merchandising Committee will assign each Vendor a spot along the Parade Route. A map will be provided to all Vendors by April 15.
- The Spokane Lilac Festival Vendor Sign must be displayed in Booth at all times.
- The Spokane Lilac Festival will issue official badges to those authorized to sell products within the booth. The Vendor Badge must be worn by all members of the sales force including managers.
- No political signs are permitted.
- Material may not be thrown to spectators.
- No firearms, fireworks or open flames are permitted.
- Use, sale and/or possession of alcoholic beverages or illegal drugs are forbidden.
- Vendors must be appropriately attired.
- Generator Power MUST be 85 db or lower. Electrical power can be obtained from the Lilac Festival Association for \$500.00.
- Vending of "Silly String," horns, popping guns, popping cap guns or popping or explosives of any kind, or other potentially dangerous or disruptive merchandise, is strictly prohibited.
- **Vendor Cancellations:** Vendor must notify the Lilac Festival Merchandising Committee of cancellation prior to May 1 for refund. Cancellations after May 1 will not be eligible for refund of the Vendor Application Fee.

**HOLD HARMLESS AGREEMENT**

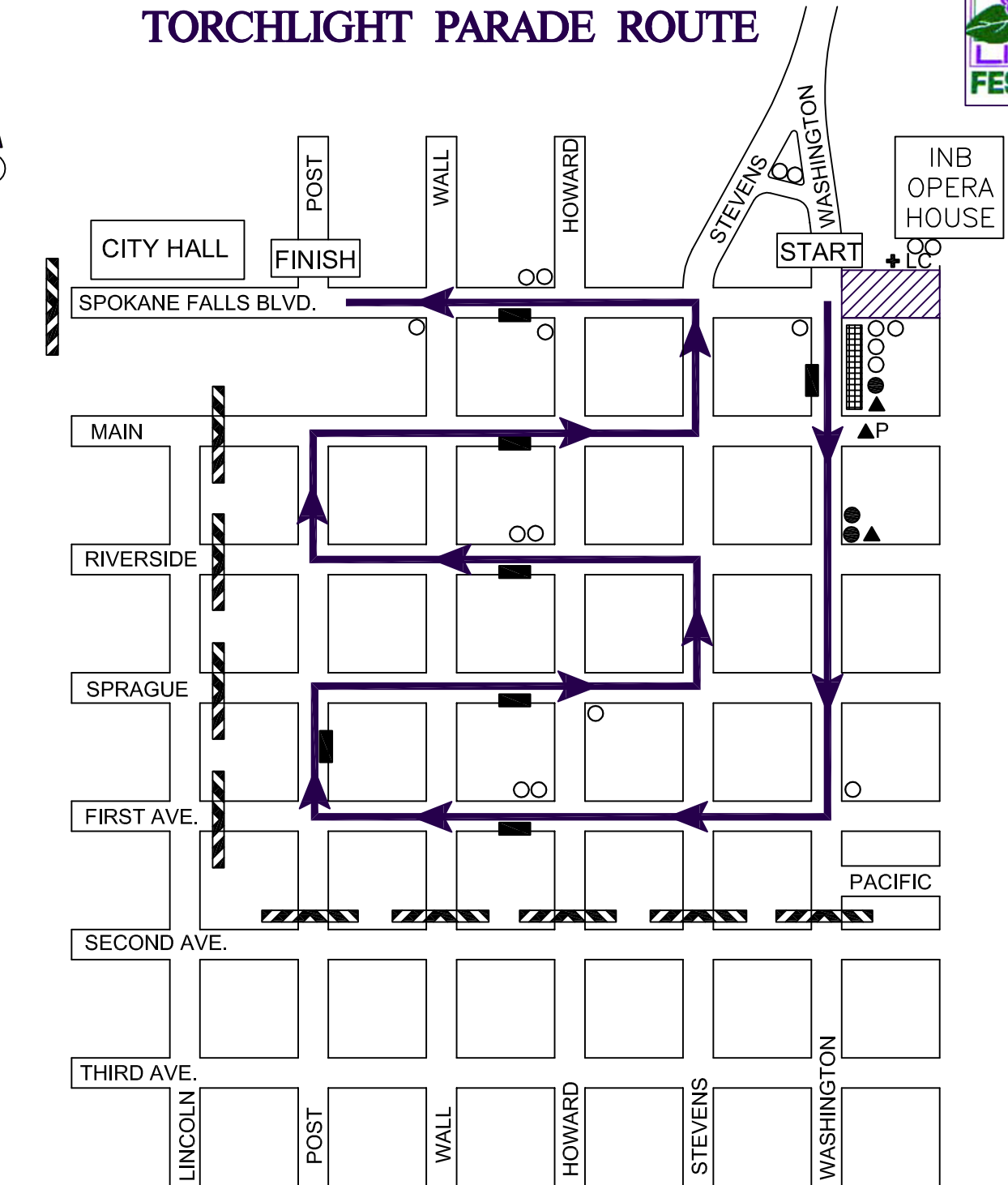
